AAK-PC products and NMPA registrations:

AAK has the intention to register the product in the NMPA data base. The status of the are found in the tables below.

The tables include the Trade name, the INCI name and the NMPA number related to the trade name in combination with the INCI name. For selected Tradenames, several INCI's have been registered, thus receiving different NMPA numbers. In addition, the historical highest usage level reported in China for leave on and rinse off are reported.

The NMPA registration require among many aspects a note of the highest historical used level in China for leave on and rinse off products. These are based on the IECIC list, and the ingredient is in China considered safe to be used under this level. However, the NMPA allow inclusion of a selection of other sources to represent the highest usage level reported. AAK has included those when relevant. A customer may use these to further defend a safe usage level.

Table 3. includes a list of the "Risky Substances". AAK's overall safety system is based on risk analysis (HACCP) of the entire supply chain. In the monitoring program raw materials, additives and final products are regularly sampled and analyzed according to a schedule, and analytical results for potential contaminants are monitored. This program is a part of and serves as a supplementary check on the effectiveness of the food safety system.

The registrations number are valid until future notice.
